**Annual Checkrides**

In accordance with Section 5 of the club *Operating Procedures*, all members are required to receive an annual flight check by a board approved CFI between December 1<sup>st</sup> and March 1<sup>st</sup>.

Members must also show proof that they have attended a minimum of two safety seminars during the past year. New members that have been in the club for six months or less require at least one safety seminar. Alternatives to the two safety seminars include completion of a CFI renewal course or any FAA Wings phase for airplanes, earning a new or additional rating, completing a BFR or taking an FAA required Part 135/121 checkride. Completing an AOPA Air Safety Foundation online course will qualify as one seminar as well.

The aircraft lock combinations will be changed in mid-April and only those members that have successfully completed the annual checkride will receive the new combinations.
